

### Employed

Income documents, any of the following:

- Latest one (1) month payslip
- Certificate of Employment and Compensation – issued within the last six (6) months
- Latest ITR

### Self-Employed/Professionals

- Latest one (1) year Audited Financial Statement (AFS) with at least the previous year's comparative financials or Bank Certificate with at least 3 months Average Daily Balance (ADB)
- SEC/DTI Certificate of Registration
- Business permit/Mayor's permit
- Latest three (3) months bank statements
- List of three (3) trade references at least one (1) supplier and one (1) customer with contact details
- Latest GIS (if corporation)
